



## **RULES OF THE PENZANCE HC**

### **LUCKY SHOT CLUB**

- 1) The name of the competition is The Penzance HC Lucky Shot Club.
- 2) The objective of the Penzance HC Lucky Shot Club is to raise funds for the general purpose of Penzance Hockey Club CIO (the Club), based at Penzance Astro Park, St Clare, Penzance, Cornwall TR18 3DX. All surplus income over expenditure (comprising direct costs and prizes) shall be donated to the Club.
- 3) The Penzance HC Lucky Shot Club will be administered by the Lucky Shot Club Secretary, duly appointed by the Trustees of Penzance HC CIO.
- 4) The Penzance HC Lucky Shot Club will be open to anybody aged 16 or over residing in the UK and is not restricted to Club members nor limited in number of entries. Entrants are each entitled to purchase up to ten numbers. An Entrant becomes a participant in the Penzance HC Lucky Shot Club on receipt by the Club of the Entrant's first payment.
- 5) The price for each entry is £5 per monthly draw for one number and is payable in advance before the published deadline.
- 6) Winning entries will be selected through a draw (the Draw) taking place up to twelve times per year. Draws will be made by using an electronic Random Number Generator or other such means as the Penzance HC Lucky Shot Club Secretary deems appropriate. Draws will be held in the Clubhouse or such other venue as the Penzance HC Lucky Shot Club Secretary may determine and in the presence of at least one member of the Management Committee, their nominees or member of the Hockey Committee. Dates and times of each Draw will be advertised in advance to Entrants.
- 7) If payment for an Entry has not been received by the date of that Draw, the Entrant is not entitled to receive any prize. Reserve numbers will be drawn every Draw which will be used in any instance where the winning number is not valid including where payment has not been received in advance for any winning entry.
- 8) The total value of prizes to be paid (the Prize Pot) following any Draw will not exceed 50% of the total value of Entries received in the period covered by the Draw. The

balance (after deducting direct costs) will be used for the development of the club. Bulletins explaining amounts raised and spent will be provided regularly to Entrants.

9) Prize money will be paid on the following basis:

1<sup>st</sup> Number drawn 60% of Prize Pot

2<sup>nd</sup> Number 25% of Prize Pot

3<sup>rd</sup> Number 15% of Prize Pot

10) The winner of each Draw will be notified as soon as possible after the Draw to arrange payment via bank transfer. If a winner cannot be contacted after one month, the winnings will be placed into Club funds. A list of prize-winners for each Draw will be shared with Entrants and published, unless winners ask for anonymity.

11) No prize for a winning Entry will be paid to any other person than the Entrant, to anyone under 16 years old, or paid if the entry price for that Draw has not been received. It is the responsibility of each Entrant to ensure they have paid for their entry to the Penzance HC Lucky Shot Club before each Draw. Under no circumstances will any entry monies be refunded.

12) The management of the Penzance HC Lucky Shot Club shall be vested in the Penzance HC Lucky Shot Club Secretary to operate in accordance with the Rules as published on the club website or alternative medium. The Rules may only be amended by the Management Committee and any changes will be notified to Entrants.

13) Any complaint pertaining to the Penzance HC Lucky Shot Club will be adjudicated by the Penzance HC Lucky Shot Club Secretary, who must consult with at least two Management Committee members, following which their decision will be final. If a complaint relates to the outcome of a Draw, it must be made in writing to the Penzance HC Lucky Shot Club Secretary at [carnview8@sky.com](mailto:carnview8@sky.com) within seven days of the notification of the outcome of the Draw to which it relates.

14) A statement of the receipts and payments for the Penzance HC Lucky Shot Club will be included in the Club's annual accounts.

15) The Penzance HC Lucky Shot Club is intended to be a Small Society Lottery under the provisions of the Gambling Act 2005. Penzance Hockey Club is licensed under the Gambling Act 2005 by Cornwall County Council, with registration number LI25\_000779.
